ORDER DENYING THE UNITED STATES TRUSTEE'S MOTION TO DISMISS CASE

- the United States Trustee's motion to dismiss the Debtors' chapter 7 case for abuse of the bankruptcy system under § 707(b)(1), based upon a presumption of abuse under § 707(b)(2), is time-barred; and
- the United States Trustee's motion to dismiss the instant case under § 707(b)(3)(B), is denied due to the movant's failure to demonstrate abuse based upon the totality of the circumstances.

Accordingly, the United States Trustee's motion to dismiss is DENIED in toto.
