2. PRACTICE TIPS FOR PARTICIPATING IN A ZOOM HEARING

JODY KENNEDY & JUDGE BROWN

- (1) The courtroom deputy will email the Zoom meeting link & Zoom meeting telephone number to all attys who have appeared in the case, and will email this info no later than the day before the hearing.
- (2) Attys should share this Zoom info *only with* their client (if appearing) and other attys.
- (3) It's important for attys to contact the courtroom deputy the day before the hearing if they intend to appear, and to specify at which hearing, whether by Zoom video or Zoom telephone, and if the atty intends to appear by telephone only, the atty needs to provide her with the telephone number from which they (and their client, if any) will be calling
 - o otherwise they may not be brought into the hearing (we will be vigilant about security)!
- (4) It is crucial that attys participating in Zoom hearings
 - (a) have their phones / Zoom connection on *audio mute* when not talking, and
 - (b) do not use speaker phones.
- (5) When an atty or party calls into the Zoom hearing, they will find themselves in "a Zoom waiting room," and they will remain there until the Court is ready to address the matter in which they want to appear, and the courtroom deputy lets them in to the actual Zoom hearing.

3. UST EXTENSION OF TELEPHONIC & VIDEO 341 MEETINGS

LISA PENPRAZE

- ➤ as of 6/12/20, the requirement that §341 mtgs in Region 2 be conducted by telephone or video appearance is extended to apply to all cases filed through 10/10/20
- ➤ this is subj to the UST or T in any case determining an in person mtg is necessary

4. STUDENT LOAN MANAGEMENT PROGRAM JUDGE BROWN, MELISSA RANALDO & HEATHER COOPER

- > the DoE has worked with ch 13 trustees and Ds' attys to formulate a SLM program they approve
 - o with input from the DoE working group, and the availability of portals, the VTB SL TF & Ct are exploring if and how to incorporate the possibility of SL management into bk cases in VTB
 - o seeking input on this
- would not be a mandatory program (all relief available is available outside of bk'cy w/o using SLM)
- > to extent Ds wish to seek, choose, and implement a different SL repmt plan, they may do so w/ this
- > envision this option being available in all chapters

- ➤ Next Gen goes live Monday 7/13
- ➤ Each atty MUST
 - (a) upgrade their PACER account ASAP or will be unable to file in CM/ECF starting on 7/13/20, and
 - (b) link their PACER to the CM/ECF NextGen system on or after the Go Live date of 7/13/20.
- ➤ IMPORTANT NOTE: The CM/ECF system will be unavailable from the close of business on Friday, July 10th until the commencement of the business day on Monday, July 13th.

- ➤ How to file tax retns outstanding on the petition date and necessary for ch 13 plan conf:
 - O During the pandemic (and for the foreseeable future), the IRS Bk'cy Specialists for Vt (Kathleen Blais and Sandra Rummel) will be accepting outstanding, signed tax returns (w/all attachments) from Ds' attys or the T by fax and email,
 - i.e., they will <u>not</u> require blue-ink signed returns by 1st class or overnight mail.
