Over the past few years we have communicated the plan to move the bankruptcy court clerk's office from Rutland to Burlington and, more recently, we have provided periodic updates regarding the progress of building renovations at the Burlington Federal Building with respect to our new quarters. The renovations are now nearing completion and <u>the move is scheduled for October 20, 2015</u>. Information regarding the bankruptcy court clerk's office's new location follows.

Effective Wednesday, October 21, 2015,

- 1. the bankruptcy court court's clerk's office will be located on the second floor of the U.S. Post Office and Courthouse building at 11 Elmwood Avenue in Burlington, Vermont; and
- 2. as of 8:30 a.m. that day, the bankruptcy court will begin accepting filings at its Burlington location, and <u>will no longer accept filings in Rutland</u>.

Although movers will be loading the moving van at the clerk's office's Rutland location on Tuesday, October 20, the office will remain open and accept filings during its regular operations hours, 8:30 a.m. - 5:00 p.m.

We do not anticipate any disruption in the office's ability to timely file documents, field telephone calls, provide unimpeded access to the court's website, or provide uninterrupted access to the CM/ECF system. If there is any disruption to the court's information technology or communication systems during the move, it will likely be minimal.
