A voluntary petition by an individual or an individual and spouse may be paid in no more than four (4) installments, upon application to the Court.

² The fee for filing a petition consists of a filing fee, an administrative fee, and, for chapter 7 petitions, a trustee surcharge, combined here for simplicity.

³ This is a mandatory fee in addition to the fee for appeals and cross appeals. It is due upon filing and may not be waived or deferred.

⁴ The fee for **requesting** a direct appeal or cross appeal from a bankruptcy court decision to the Court of Appeals is \$298 (\$293 appeal fee + \$5 notice of appeal fee). If the Court of Appeals **authorizes** the direct appeal, an **additional** fee of \$157 is due to the Bankruptcy Court.

⁶ The exemption from paying the fee to reopen a case can be applied in only two situations: (1) reopening a case to permit a party to file a complaint to obtain a determination under Rule 4007(b); or (2) reopening a case when a creditor is violating the terms of the discharge under 11 U.S.C. § 524. The court may defer payment of the fee from trustees pending discovery of additional assets. If payment is deferred, the fee shall be waived if no additional assets are discovered.

⁷ No fee is charged to change the address of a listed creditor, or to add/change the name and address of a listed creditor's attorney.
