#### **ORDER**

# <u>DIRECTING THAT CERTAIN DOCUMENTS RELATED TO THE EXAMINER'S REPORT</u> (THAT WERE ORIGINALLY FILED UNDER SEAL) BE ENTERED ON THE COURT DOCKET

WHEREAS, on July 8, 2005, Harvey R. Miller, in his capacity as the Court appointed examiner (the "Examiner") filed his report with the Court under seal (doc. # 1623) (the "Report"); and

WHEREAS the transcripts of the hearings regarding the Report and various motions related to the Report were also filed under seal (collectively, the "Related Documents"); and

WHEREAS, on August 16, 2005, the Court issued a Memorandum of Decision (i) granting the motions to unseal the Report, (ii) denying the motions to seal the Report, and (iii) granting the alternative relief of redacting certain portions of the Report and adding a cautionary ledger to the Report (doc. # 1798) (the "August 16<sup>th</sup> Decision"); and

WHEREAS in the August 16<sup>th</sup> Decision, the Court indicated that it would issue a separate order applying the rationale of the August 16<sup>th</sup> Decision to the Related Documents and specifying which, if any, of the Related Documents would be entered on the public docket;

After due consideration of the record and analysis of each of the Related Documents, THE COURT FINDS that most of the Related Documents should be entered on the docket. Since the Report is part of the public record, there is no basis under § 107(b) for the Related Documents to be withheld from public access. Upon entry of this Order, each of the Related Documents that are to be unsealed shall be available to the public on the Court's docket as an attachment to the cover page or notice of filing which was publicly filed at the time the subject Related Document was filed under seal.<sup>1</sup>

THE COURT FURTHER FINDS that in the interest of maintaining the confidentiality of those portions of the Report that have been redacted, and for the reasons set forth in the August 16<sup>th</sup> Decision, certain Related Documents will not be entered on the Court's docket or publicly available. In particular, the privilege logs, papers that quote verbatim from privilege logs, the Examiner's original [unredacted] Report and papers that quote that version of the Report, shall all remain under seal, pursuant to § 105.
