**STANDING ORDER
#02-2**

WHEREAS Vt.LBR 2090-1(a) requires that once the Electronic Case Filing System is fully implemented all attorneys must register for the Electronic Case Filing System as a pre-requisite to filing papers in this Court, unless, upon motion, said registration is excused by the Court; and

WHEREAS the Electronic Case Filing System is fully implemented in this Court as of April 2, 2002; and

WHEREAS Standing Order #02-1, *Delay in Implementation of Vt. LBR 2090-1(a)*, extended to October 17, 2002 the date for attorneys to register for the Electronic Case Filing System; and

WHEREAS many attorneys who regularly practice in this Court have not yet had the opportunity to complete the CM/ECF training which is a pre-requisite to registration for the Electronic Case Filing System;

IT IS THEREFORE ORDERED that any attorney who has registered for the Electronic Case Filing System by October 31, 2002, or who has registered for training by October 31, 2002 will be considered in compliance with Vt.LBR 2090-1(a) and will be eligible to practice in this Court.
